#### CHAPTER 1

#### INTRODUCTION

### **Understanding Human Trafficking**

Human trafficking is a grave violation of human rights. It's a form of modern-day slavery that affects millions of people globally, including many children and young adults. This handbook aims to equip students with the knowledge to recognize, understand, and combat this crime. By learning about human trafficking, you can become an advocate for change and help protect yourself and others from exploitation.

What is Human Trafficking? Human trafficking involves the use of force, fraud, or coercion to exploit a person for labor or commercial sex. It's important to distinguish it from human smuggling. Human smuggling is about illegally

moving a person across a border with their consent. Human trafficking is about the exploitation of a person, regardless of whether they crossed a border legally or illegally.

### The Palermo Protocol defines human trafficking as:

The recruitment, transportation, transfer, harboring or receipt of persons, by means of the threat or use of force or other forms of coercion, of abduction, of fraud, of deception, of the abuse of power or of a position of vulnerability or of the giving or receiving of payments or benefits to achieve the consent of a person having control over another person, for the purpose of exploitation. Exploitation shall include, at a minimum, the exploitation of the prostitution of others or other forms of sexual exploitation, forced labor or services, slavery or practices similar to slavery, servitude, or the removal of organs

### **CHAPTER 2**

### The Different Types of Human Trafficking

While sex and labor trafficking are the main categories, human trafficking can manifest in various forms.

**Sex Trafficking**: This is often what people think of when they hear "human trafficking." Victims are forced into prostitution, pornography, or other forms of commercial sexual exploitation. Traffickers often use a combination of manipulation, threats, and physical violence to control their victims.

Labor Trafficking: This involves forced labor in various industries, such as agriculture, domestic work, construction, manufacturing, and hospitality. Victims are often subjected to

grueling hours, unsafe working conditions, and little to no pay. They're often trapped by debt bondage, where they are told they must work to pay off a fabricated debt.

**Domestic Servitude:** A specific type of labor trafficking where a person is forced to work as a domestic servant in a private home. Victims are often isolated, have their passports or IDs confiscated, and are not allowed to leave the premises. They are often subjected to physical and psychological abuse.

Forced Criminality: Traffickers may force victims to engage in illegal activities, such as drug trafficking, theft, or forced begging. This is a tactic used to further control the victim, as the threat of being reported to law enforcement is a powerful tool.

**Organ Trafficking:** This is the illicit trade of human organs for transplantation.

Victims are often deceived or coerced into having their organs surgically removed.

#### Who Are the Victims?

Anyone can be a victim of human trafficking, regardless of their age, gender, race, or socioeconomic background. However, some populations are more vulnerable than others.

#### **Vulnerability Factors**

- Poverty: Individuals and families struggling with poverty are often lured by false promises of well-paying jobs and a better life.
- Lack of Education: Limited access to education can make individuals more susceptible to deceptive recruitment tactics.
- **Instability**: People in unstable situations, such as those who are homeless, runaways, or displaced by conflict or natural disasters, are at a higher risk.

- Social Isolation: Individuals who lack a strong support system of family and friends are easier for traffickers to isolate and control.
- Previous Abuse or Trauma: A history of physical, emotional, or sexual abuse can make a person more vulnerable to exploitation.

#### CHAPTER 3

#### The Traffickers' Profile

Traffickers can be anyone: a stranger online, a new friend, a romantic partner, or even a family member. They often present themselves as caring and trustworthy, using a tactic called "grooming" to build a relationship and gain a victim's trust before revealing their true intentions. They prey on the vulnerabilities of their victims, promising a better life, a romantic relationship, or a job opportunity that seems too good to be true.

**The Recruitment Process:** The Lure of Deception

Traffickers are masters of manipulation and deception. They use various methods to recruit their victims.

#### **Common Recruitment Tactics:**

- The "Loverboy" Method: This is a common tactic in sex trafficking. A trafficker, often a young man, builds a romantic relationship with a young person. They shower the victim with attention, gifts, and compliments to gain their trust. Once the victim is emotionally invested, the trafficker slowly begins to isolate them from their friends and family and introduces them to the world of commercial sex.
- Job Scams: Traffickers advertise fake jobs with high pay and great benefits, especially online. When the victim arrives, they are told the conditions have changed, they are in debt, or their documents have been seized, trapping them.

- **False Promises of a Better Life**: Traffickers promise victims, especially those from low-income or war-torn countries, a chance to escape poverty and live a life of luxury.
- Kidnapping and Abduction: While less common than other methods, some victims are physically abducted and forced into exploitation.

### **The Signs of Human Trafficking**: What to Look For

Recognizing the signs of human trafficking is crucial for helping victims. The signs can be subtle and may vary depending on the type of trafficking. Physical Signs

- **Signs of physical abuse**: Unexplained bruises, burns, or other injuries.
- Malnutrition or poor hygiene: The person may appear underweight, unkempt, or neglected.

- Signs of poor health: Lack of medical care for obvious illnesses or conditions.
- Tattoos or branding: The person may have a tattoo or brand indicating ownership by a trafficker.
   Behavioral and Psychological Signs
- **Fear and anxiety**: The person may appear fearful, nervous, or jumpy.
- Submissive or withdrawn behavior: They may be hesitant to speak, make eye contact, or interact with others.
- Signs of control: A person may be controlled by a partner, friend, or "family member" who speaks for them, restricts their movements, or holds their documents.
- Lack of personal possessions: They may not have their ID, phone, or money.

They exploit factors like poverty, unemployment, lack of education, and the desire for a better life abroad.

# 16. What should I be cautious about when dealing with a recruitment agent?

Verify the agent's license and credentials. A legitimate agent won't ask you to lie about your purpose of travel.

### 17. What are signs that someone I know might be a victim of trafficking?

They may have new, expensive belongings without a clear source of income, seem withdrawn or fearful, have injuries, or be unable to communicate freely.

### 18. How can I identify a fake travel agency?

They often operate without a physical office, have no online presence, and provide vague or incomplete information.

### 19. Is it a red flag if someone promises to handle all my travel documents for me?

Yes, it is. A legitimate process requires your direct involvement. Legal Framework in Nigeria

The Trafficking in Persons (Prohibition) Enforcement and Administration Act, 2015.
